- the Municipality of L'Isle-aux-Allumettes undertakes to be solely responsible and to indemnify and the Governments of Canada, Quebec and their ministers, officers, employees and agents from and against all claims, demands, losses, damages and costs of any kind due to an injury to a person, death, damage to property or loss of property attributable to a willful or negligent act arising directly or indirectly from investments made with the financial assistance obtained within the framework of the TECQ 2014-2019 program;
- the Municipality of L'Isle-aux-Allumettes approves the content and authorizes the sending to the Department of Municipal Affairs and Land Occupancy of the proposed work program attached hereto and all other documents required by the Department to receive the contribution which will be confirmed in a letter from the Minister of Municipal Affairs and Land Occupancy;
- the Municipality of L'Isle-aux-Allumettes is committed to meeting the minimum municipal infrastructure capital threshold set at \$ 28 per capita per year, for a total of \$ 140 per capita for all five years of the program;
- the Municipality of L'Isle-aux-Allumettes undertakes to inform the Ministry of Municipal Affairs and Land Occupancy of any changes to the work program approved by this resolution;
- the Municipality of L'Isle-aux-Allumettes certifies by this resolution that the attached work programs include true realized costs and reflects the projected expenditures for eligible works through to December 31, 2019.
