It is therefore proposed by Councillor Sallafranque and resolved that the new Procedure concerning the receipt, examination and treatment of Complaints in the context of Awarding a Contract be adopted.

Proposed Special Flood Zones and Draft Decree 137-19/07

WHEREAS the Municipality was affected by the floods of 2017 and

severely affected by the flooding of 2019;

WHEREAS the Government of Quebec released a draft decree

regulating flood zones and mapped a proposed new Special

Intervention Zone, on June 17th, 2019;

WHEREAS the proposed map encompasses a territory much greater

than those found within 0-20-year flood marks, the 2017

flooded territories and the 2019 flooded territories;

WHEREAS the proposed changes will prohibit many new constructions

and reconstructions in areas which have never seen water;

WHEREAS the proposed changes will have a grave negative impact on

> economy, development, tourism, infrastructure funding, municipal budgets and taxation;

It is therefore proposed by Councillor McGuire and unanimously resolved that this Municipality strongly oppose the proposed decree and special intervention zones released by the Government of Quebec and to authorize the Director General to provide the necessary comments and proposed corrections directly to their representatives.
